I have since noted that the total figures at the end of each 'type' column were added together incorrectly by the responder, rendering the figures quoted in the original data sheet supplied together with my petition, incorrect].

The evidence supports items which will be raised at the meeting, and committee members may wish to familiarise themselves with these beforehand. They may alternatively be used as a useful reference afterward.
