## **TUESDAY 17 APRIL 2012**

### Scottish Government—

The Committee agrees that COSLA would be an appropriate body to take this work forward on a practical level but asks that the Scottish Government take a strategic lead in requesting that COSLA establish a working group to consider the issues raised in the petition (overbreeding and abandonment) not just in relation to Staffordshire Bull Terriers but in relation to all dogs.

### Scottish Government—

The Committee welcomes your willingness to take part in discussions with stakeholders to help resolve the issue of the unlicensed breeding and sale of dogs by certain members of society and the abandonment of these and any other dogs.

On this basis the Committee would be grateful if you would take the lead in establishing a working group, with relevant stakeholders, to discuss examples of best practice in tacking these issues and to identify how local authorities and other professional and voluntary organisations can work together to improve the current situation. The Committee would appreciate you confirming that you will take this work forward, along with a draft remit and membership for the group along with a timetable for taking the work forward.
